RATES OF POSTAGE, CHARGES AND TERMS & CONDITIONS AS DETERMINED UNDER
REGULATION 6 OF THE ISLE OF MAN POST OFFICE AUTHORITY
(OVERSEAS PARCEL POST) REGULATIONS 1987

MADE BY THE POST OFFICE - 26 May 1995
COMING INTO OPERATION - 12 June 1995

Rates of Postage

1. (1) Subject as provided in paragraphs (2) and (3) of the Determination made on 27 May 1993 (Ref OPP1/93) there shall be charged and paid on outgoing parcels, postage at the rates specified in Table 1, Part 1.
 - (2) In the case of outgoing parcels (other than air parcels):
 - (a) addressed to a person on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the Isle of Man), or
 - (b) posted for transmission through a British Forces' Post Office to a member of the armed forces of the United Kingdom or of any other Commonwealth country serving outside the Isle of Man, or to a member of the armed forces of a State allied to the United Kingdom serving outside the Isle of Man with the armed forces of the United Kingdom or of any other Commonwealth country, there shall be charged and paid thereon postage at the rates specified in Table 1, Part 2.
 - (3) In the case of outgoing parcels which exceed the limits of weight specified in paragraph 4(1) of the Determination made on 27 May 1993, and which the Post Office allows to be posted, there shall be charged and paid thereon postage at rates to be fixed by the Post Office.

Replacement of Previous List of Postage Rates

2. (1) The rates specified in Table 1, Parts 1 and 2 and Table 2 of the Determination made on 27 May 1993 are replaced by this Determination.

1. This Determination is made under the provisions of the Isle of Man Post Office Authority (Overseas Parcel Post) Regulations 1987 (Government Circular No. 290/87).
2. This Determination (OPP 1/95) fixes the rates of postage for overseas and Forces parcels and sets out the charges, terms and conditions applying thereto.
3. This Determination comes into operation on the 12 June 1995.

12 JUNE 1995****CHARGES FOR ADDITIONAL SERVICES**

- (i) Fees for Customs Clearance (Inward) - (Paragraph 5) and Parcels held in bond pending customs clearance - Paragraph 19 (1)
First 10 working days free, each subsequent working day £4.75 per parcel and each working day thereafter £1.10 per day.

- (ii) Compensation - Paragraph 16(1)
The maximum compensation payable in respect of an Economy parcel shall be £20.

- (iii) Compensation - Paragraphs 16(2)
The compensation payable in respect of a Standard parcel (air mail) sent to countries (other than those excluded by the Authority) shall not exceed £250 per parcel.
