Road Traffic Regulation Act 1985

The Douglas Promenades
(Provision of Parking)(Amendment)(No1) Order 1995

Coming into Operation: 13th April 1995

In exercise of the powers conferred on the Department of Transport by Section 11 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers the following Order is hereby made :-

Citation and Commencement

1. This Order may be cited as the Douglas Promenades (Provision of Parking)(Amendment) (No 1) Order 1995 and shall come into operation on 13th April 1995

Amendment of Principal Order

2. The Douglas Promenades (Provision of Parking)(No 1) Order 1994 (b), shall be amended in accordance with the following provisions of this Order

Amendments

3. Delete Article 6 (1) (b) of Part II and insert the following entry:-

"(b) (i) In the case of the parking place specified in Schedule 2, paragraph 2 -
for vehicles displaying a valid disabled persons badge for a longer period than 30 minutes.

(ii) In the case of the parking place specified in Schedule 2 paragraph 3 -
for a longer period than 15 minutes"

4. Delete the first column of paragraph 1 to Schedule 2 and insert the following entry :-

"From a point 4 metres north of the southerly boundary of the Britannia Hotel northwards to a point opposite the entrance doors to the Wallberry Suite at the northern end of the Sefton Hotel - a distance of 43 metres"

5. Delete the first column of paragraph 2 to Schedule 2 and insert the following entry :-

" From a point opposite the entrance doors to the Wallberry Suite at the northern end of the Sefton Hotel northwards for a distance of 12 metres"

6. Delete the first column of paragraph 3 to Schedule 2 and insert the following entry :-

"From the northern limit of the Disabled Parking bay northwards to the southern boundary of The Arcade - a distance of 18 metres"

7. Delete the third column of paragraph 7 to Schedule 2 and insert the following entry :-

"Motor Cars
Class "A" vehicles"

8. Delete the fifth column of paragraph 7 to Schedule 2 and insert the following entry :-

"Monday to Saturday excluding Christmas Day, Boxing Day and New Years Day"

9. Delete the sixth column of paragraph 7 to Schedule 2 and insert the following entry :-

" 8 am to 6 pm"

Explanatory Note

(This note is not a part of the Order)

The effect of this Order is :-

(i) to redefine the limits of the taxi rank on the west side of Harris Promenade.

(ii) to redefine the limits of the disabled parking bay and the parking areas for Class "A" vehicles on the west side of Harris Promenade

(iii) to reduce the maximum period of waiting to 30 minutes for disabled persons vehicles and 15 minutes for Class "A" vehicles on the west side of Harris Promenade

(iv) to remove the taxi rank on the east side of Harris Promenade and replace it with a parking area for Class "A" vehicles.
