## **IMMIGRATION (DESIGNATION OF TRAVEL BANS) ORDER 2013**

*Laid before Tynwald:* 19 February 2013  
*Coming into Operation:* 1 March 2013

The Council of Ministers makes the following Order under section 8B(5) and (6) of the Immigration Act 1971 (of Parliament), as that Act has effect in the Island<sup>1</sup>.

### **1 Title**

This Order is the Immigration (Designation of Travel Bans) Order 2013.

### **2 Commencement**

This Order comes into operation on 1 March 2013.

### **3 Interpretation**

In this Order, “**the Act**” means the Immigration Act 1971 (of Parliament), as it has effect in the Island.

### **4 Designated instruments**

The instruments listed in the Schedule are designated under section 8B(4) and (5) of the Act.

### **5 Disapplication of section 8B of the Act**

Section 8B of the Act does not apply in any case if—

- (a) failure to apply the section would not be contrary to the United Kingdom’s obligations under any of the instruments designated by article 4 of this Order,
- (b) to apply these provisions would be contrary to the United Kingdom’s obligations under the Convention for the Protection of Human Rights

and Fundamental Freedoms, agreed by the Council of Europe at Rome on 4 November 1950 as it has effect for the time being in relation to the Isle of Man, or

- (c) to apply the section would be contrary to the United Kingdom's obligations under the Convention relating to the Status of Refugees done at Geneva on 28<sup>th</sup> July 1951 and the Protocol to that Convention.

## **6 Revocation**

The Immigration (Designation of Travel Bans) (No. 2) Order 2012<sup>2</sup> is revoked.

*EXPLANATORY NOTE*

*(This note is not part of the Order)*

This Order revokes and replaces the Immigration (Designation of Travel Bans) (No.2) Order 2012. Any person named by or under an instrument listed in the Schedule to this Order or falling within a description in such an instrument will be excluded from the Isle of Man (subject to the exceptions specified in Article 5).

The Order prescribes a revised list of instruments of the United Nations and the European Union which are designated for the purpose of section 8B(4) and (5) of the Immigration Act 1971, as that Act has effect in the Island.

The changes made with this Order concern amendments to Part 2 of the Schedule to list the following EU instruments: Council Decision 2012/642/CFSP of 15 October 2012 (Belarus) (which replaced Council Decision 2010/639/CFSP of 25 October 2010 (Belarus) and all the subsequent amending and implementing Council Decisions); Council Implementing Decision 2012/516/CFSP of 24 September 2012 (Republic of Guinea-Bissau); Council Decision 2012/635/CFSP of 15 October 2012 (Iran); Council Decision 2012/527/CFSP of 27 September 2012 (Republic of Moldova); Council Decision 2012/633/CFSP of 15 October 2012 (Somalia); and Council Decision 2012/739/CFSP of 29 November 2012 (Syria) (which replaced Council Decision 2011/782/CFSP of 1 December 2011 (Syria) and all the subsequent amending and implementing Council Decisions).
