Payment of Members' Expenses Act 1989

PAYMENT OF MEMBERS' EXPENSES (SPECIFIED BODIES) (AMENDMENT) ORDER 2013

Laid before Tynwald: 19th February 2013

Coming into operation in accordance with article 2

The Treasury makes the following Order under section 4(1)(a) of the Payment of Members' Expenses Act 1989.

1 Title

This Order is the Payment of Members' Expenses (Specified Bodies) (Amendment) Order 2013.

2 Commencement

- (1) Except as specified in paragraph (2), this Order comes into operation on 1 March 2013.
- (2) The following provisions are deemed to have come into operation on the date specified¹—
 - (a) article 3(2)(a) and (b), on 1 June 2009;
 - (b) article 3(2)(d), on 1 November 2007;
 - (c) article 3(2)(e), on 1 July 2009; and
 - (d) article 3(2)(f), on 8 July 2011.

3 Amendments

- (1) The Payment of Members' Expenses (Specified Bodies) Order 2003² is amended as follows.
- (2) In Part 2 of Schedule 1—

- (a) in paragraph 19, for “The Isle of Man Board of Education” substitute **“The Education Council”**;
 - (b) omit paragraph 20 (committees of the Isle of Man Board of Education);
 - (c) omit paragraph 29 (Isle of Man Gambling Control Commissioners);
 - (d) in paragraph 30(b) for “a board of visitors” substitute **“an Independent Monitoring Board”**;
 - (e) in paragraph 36, for “The Chronically Sick and Disabled Persons Committee” substitute **“The Tynwald Advisory Council for Disabilities”**; and
 - (f) in paragraph 33, for “The Scientific Advisory Committee established under section 3 of the Endangered Species (Import and Export) Act 1981” substitute **“The Wildlife Committee established under section 1(2) of the Endangered Species Act 2010”**.
- (3) In paragraph 46³ of Part 3 of Schedule 1, for “The Overseas Aid Committee” substitute **“The International Development Committee”**.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Payment of Members' Expenses (Specified Bodies) Order 2003 (SD 39/03: "the principal Order") to take account of a number of legislative changes and changes of name of certain bodies there were not included when the principal Order was last amended in 2009 or have take place since that time.

The dates on which the amendments listed in article 3(2) are deemed to have come into operation are the dates on which the relevant legislative changes came into operation.

Non-Tynwald members of bodies specified in an Order made by the Treasury under section 4(1) of the Payment of Members' Expenses Act 1989 are entitled to attendance allowances and (by virtue of section 5(1)(c)(ii) of that Act) to travelling allowances.
