IRAN SANCTIONS (HUMAN RIGHTS) (AMENDMENT) REGULATIONS 2013

*Laid before Tynwald: 19 February 2013
Coming into operation in accordance with regulation 2*

The Council of Ministers makes the following Regulations under sections 2B and 2C of the European Communities (Isle of Man) Act 1973.

1 Title

These Regulations are the Iran Sanctions (Human Rights) (Amendment) Regulations 2013.

2 Commencement

These Regulations come into operation immediately after they are made.

3 Amendment of the Iran Sanctions (Human Rights) Regulations 2012

(1) The Iran Sanctions (Human Rights) Regulations 2012¹ are amended as follows.

(2) In regulation 3 for the definition of “the EU Regulation” substitute—

☞ **“the EU Regulation”** means Council Regulation (EU) No 359/2011² of 12 April 2011 concerning restrictive measures against Iran as amended by –


(a) Council Implementing Regulation (EU) No 1002/2011³ of 10 October 2011 implementing Article 12(1) of Regulation (EU) No 359/2011 concerning restrictive measures directed against certain persons, entities and bodies in view of the situation in Iran;

- (b) Council Regulation (EU) No 264/2012⁴ of 23 March 2012 amending Regulation (EU) No 359/2011 concerning restrictive measures directed against certain persons, entities and bodies in view of the situation in Iran; and
- (c) Council Regulation (EU) No 1245/2012⁵ of 20 December 2012 amending Regulation (EU) No 359/2011 concerning restrictive measures directed against certain persons, entities and bodies in view of the situation in Iran,

as these instruments have effect in the Island⁶ and a reference to a numbered Article or Annex (without more) is a reference to the Article of, or Annex to, the EU Regulation so numbered. .

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Iran Sanctions (Human Rights) Regulations 2012 (SD 0479/12: “the principal Regulations”) to take account of the amendment of Council Regulation (EU) No 359/2011 by Council Regulation (EU) 1245/2012 as these EU instruments have effect in the Island by virtue of SD 0478/12 and SD 0031/13 respectively. The principal Regulations established offences and penalties for breaches of Council Regulation (EU) No. 359/2011, as applied to the Island by SD 0478 /12, and they provided for the licensing by the Treasury of activities which would otherwise be proscribed.
