ROAD VEHICLES MAINTENANCE & USE (SOUTHERN 100 ROAD RACES) ORDER 2013

Made: 3 July 2013
Coming into Operation: 8 July 2013

The Department of Infrastructure makes the following Order under section 33 of the Road Traffic Act 1985.

1 Title

This Order is the Road Vehicles Maintenance & Use (Southern 100 Road Races) Order 2013.

2 Commencement

This Order comes into operation on 8 July 2013.

3 Interpretation

In this Order—

“**Course,**” “**practice period**” and “**race period**” have the same meanings as in the Road Race Order;

“**promoter**” means the Southern 100 Motorcycle Racing Limited;

“**Road Race Order**” means the Southern 100 Road Races Order 2013.

4 Authorisation of use of certain motorcycles

(1) This article applies to a motorcycle with or without a sidecar which does not comply with all the requirements of the following Orders—

(i) Road Vehicles (Maintenance and Use) Regulations 2002, as amended by the Road Vehicles (Maintenance and Use) (Amendment) (Regulations) 2005;

(ii) Road Vehicles Lighting Regulations 1989 as applied to the Island by the Road Vehicles Lighting (Application) Regulations 1998 and amended by the Road Vehicles Lighting (Application) (Amendment)

Regulations 2001, the Road Vehicles Lighting (Application) (Amendment) Regulations 2002 and the Road Vehicles (Construction, Lighting and Use) (Amendment) Regulations 2004;

insofar as those sections which apply to a vehicle specified in paragraph (2), are suspended for the periods specified in paragraph (3).

- (2) The use on roads of a motorcycle which is competing in a motorcycle race or practice authorised by article 4 of the Road Race Order, or is being driven by a marshal in the course of his duty with the permission of the Clerk of the Course, and is being used on a journey—
- (a) travelling between the place where it is kept and a point on the Course;
 - (b) travelling from a point on the Course to the place where it is kept;
 - (c) travelling between points on the Course;

is subject to the restrictions and conditions specified in paragraph (3).

- (3) The authorisation applies to—
- (a) the closure periods referred to in the Road Races (Southern 100 Road Races) Order 2013;
 - (b) during a period commencing 3 hours before any practice period or race and ending 2 hours after that practice period or race period.

5 Duration

This Order will be in force from 8 July 2013 up to and including 11 July 2013.

This Order authorises the use on a road to or from a race or practice forming part of the Southern 100 Road Races of a motorcycle with or without a sidecar taking part in the race or practice, although it may not comply with the construction and lighting requirements applicable to motorcycles.
