This Order is the Civil Partnership (Fees) Order 2013.

2 Commencement

If approved by Tynwald, this Order comes into operation on 5 August 2013.

3 Fees

The fees specified in column 2 of the table set out in the Schedule are payable in respect of the matters specified in column 1 of the table.

4 Revocation

The Civil Partnership (Fees) (No.2) Order 2011¹ is revoked.

Civil Partnership Act 2011	
Matter	Fee
A civil partnership may be registered in the presence of a registrar (subject to availability), the registrar being present for no more than one hour -	
a) in a registrar's office -	
i. from Monday to Friday, between the hours of 9.30am and 4.30pm	£40.00
ii. on a Saturday, between the hours of 9.30am and 4.00pm	£80.00
b) at the place where one of the persons is housebound or detained	£50.00
c) in a place approved by the Chief Registrar or in (or over) the Island or its territorial waters aboard an approved aircraft, vehicle or vessel -	
i. from Monday to Friday, between the hours of 9.30am and 4.30pm	£210.00
ii. on a Saturday, between the hours of 9.30am and 4.00pm	£250.00
iii. at any other time, or on any Bank Holiday	£350.00
d) in any other place in the Island or in (or over) its territorial waters aboard an aircraft, vehicle or vessel which is not approved, but only with the consent of the owner of the place, aircraft, vehicle or vessel -	
i. from Monday to Friday, between the hours of 9.30am and 4.30pm	£210.00
ii. on a Saturday, between the hours of 9.30am and 4.00pm	£250.00
iii. at any other time, or on any Bank Holiday	£350.00
e) at a place specified in a judge's licence issued under the special procedure -	
i. from Monday to Friday, between the hours of 9.30am and 4.30pm	£80.00
ii. on a Saturday, between the hours of 9.30am and 4.00pm	£160.00
iii. at any other time, or on any Bank Holiday	£300.00
Where the presence of a registrar is required in excess of one hour, each additional hour or part thereof will incur the following fee:	
i. from Monday to Friday, between the hours of 9.30am and 4.30pm	£40.00
ii. at any other time, or on any Bank Holiday	£80.00
Notice of proposed civil partnership (whether given by both persons or only one of the persons in accordance with the applicable statutory provisions)	£30.00
Application to the Chief Registrar to shorten the waiting period	£27.50
Issue of civil partnership schedule	£10.00
Issue of judge's licence for civil partnership under the special procedure	£35.00
Correction of error in a civil partnership register	£15.00

Search of indexes kept in the General Registry and where required obtain a certified copy or certified extract of any entry in a civil partnership register:	
(i) where search is undertaken by the applicant	£0.00
(ii) where search is required to be made by Registry staff	£5.00
(iii) to obtain a certified copy or certified extract of any entry, in addition to the search fee (if any)	£10.00
