REGISTRATION OF MARRIAGES (FEES) REGULATIONS 2013

Approved by Tynwald: 9 July 2013
Coming into Operation: 5 August 2013

The Treasury makes the following Regulations under sections 20(5), 24(4), 29(2), 30(5), 35(1) and (2)(b), 37(7), 38(5) and (6), 43(2), 48, 49(2) and 51(5) of the Marriage Act 1984.

1 Title

These Regulations are the Registration of Marriages (Fees) Regulations 2013.

2 Commencement

If approved by Tynwald, these Regulations come into operation on 5 August 2013.¹

3 Fees

The fees specified in column 3 of the table set out in the Schedule are payable in respect of the matters specified in column 2. Column 1 of the table specifies the relevant sections of the Marriage Act 1984 under which the matters fall.

4 Revocation

The Marriages (Fees) Regulations 2011² are revoked.

EXPLANATORY NOTE
